Take I 90 Ranchester/Dayton exit # 9, north of Sheridan, US 14 West go up the mountain for +/- 31 miles take a right turn at Road sign Yellowstone/Teton/ Cody, (there is a trailer dump

station right before the Junction). Turn right on FS Road 15; Hi-way Department (before the Bear Lodge) follow signs to Saw Mill Flats @ 15 miles.

If you are coming from Lovell on 14A side turn left on Road 15 just past the Bear Lodge and follow the signs.

Any ATV vehicles must have WY ORV Sticker-for purchase information go to WY State Parks Trails site wyoparks.wyo.gov or call 1-877-996-7275

There will be no dogs allowed on rides and while in camp they will be leashed. No stallions will be allowed at this event.

There will be some highline areas in the trees (tree saver straps required) or you can set up your own portable corrals or electric fenced areas. USFS requires certified hay/feed cubes only. Please bring your own water for horses (there is a creek near by pending spring runoff and we will have a tank) so please bring a bucket, there will be no community tank for horses to drink from. Porta-potties will be provided. Remember Leave No Trace. Please clean up and spread your manure. USFS is requiring to be bear aware with your food containers and garbage.

Registration checkin will start Fri Aug 13 in the afternoon. We will have attendants to help with parking.

Wrist bands provided will be required for dinner Sat. night and breakfast Sun. am

WYOMING BACK COUNTRY LIABILITY RELEASE

Cloud Peak Back Country Horsemen release

I hereby make application to participate in Wyoming Back Country Horsemen (WBCH) /Cloud Peak Back Country Horsemen (CPBCH) activities. I hereby acknowledge that these activities sponsored by the WBCH/CPBCH involve risks which are inherent to equine use. In consideration of the WBCH/CPBCH accepting me as a participant in these activities, and for good and valuable consideration, I hereby release and will not sue WBCH/CPBCH officers, directors and members, chapter officials and members, agents and associates, and the owners and occupiers of the real property on or over which said activities will be conducted from any liability arising of or in connection with my travel to and from or participating in said activities or damages to myself, my animals or any of my personal property or equipment.

I hereby acknowledge that the Wyoming Recreation Safety Act (W.S.1-1-122,123), AS ADOPTED BY THE Wyoming Legislature provides as follows:

[a] Any person who takes part in any sport or recreational opportunity assumes the inherent risk of injury and all legal responsibility for damages, injury, or death to himself or other persons or property that results from the inherent risks in that sport or recreational opportunity.

[b] A provider of any sport or recreational opportunity is not required to eliminate, alter or control the inherent risks within the particular sport or recreational opportunity.

[c] Actions based upon negligence of the provider not caused by an inherent risk of the sport or recreational opportunity shall preserve pursuant to W.S. 1-1-109

A "sport or recreational opportunity" as defined by the Wyoming Recreational Safety Act includes backcountry trips and horseback riding. The Wyoming Recreation Act defines inherent risks as "any risk that is characteristic of or intrinsic to any sport or recreational opportunity which cannot reasonably be eliminated, altered or controlled."

I acknowledge that I have read the foregoing and understand that I am relinquishing any and all rights that I, my heirs, or executors, or administrators might otherwise have against the WBCH officers, directors, members, chapter officials and members, agents and associates, and the owners or occupants of the real property on or over which said activities will be conducted and that I do so voluntary.
